Message from the CEO



The world faces three big environmental crises: global warming, loss of biodiversity, and pollution of our ecosystems, a combination many organizations refer to as "The triple planetary crisis".

Climate change is exerting a significant pressure on our biodiversity, with assessments showing an accelerated loss of flora and fauna species, with consequential social, environmental and economic impacts.

In the face of these challenges, market mechanisms allow cost-effective project development, optimizing scarce resources' allocation. This approach is not exempt from critics, in particular the need for enhanced integrity, transparency, and quality of projects that benefit from those resources.

In this context, the role of standards such as Cercarbono takes on a fundamental relevance in strengthening this mechanism, envisioned as one of the most effective strategies to foster a transformational change in this crucial field.

In 2023, Cercarbono took meaningful measures in such direction, by updating its regulatory framework, and incorporating market's best practices. In addition, a robust governance model was adopted and attracted the best available talent to strengthen its human team. Close collaboration with EcoRegistry, the platform managing Cercarbono's programs and projects, allows providing assurance and transparency to all stakeholders.

This enabled Cercarbono obtaining ICROA's accreditation, as well as CORSIA's conditional approval. Even when these are important achievements, we consider them as a means to keep working and improving in a comprehensive and continuous manner, in order to provide the confidence required by all stakeholders.

We fully believe that market mechanisms will foster transformational changes in other less explored areas: circular economy and biodiversity. In 2023, Cercarbono together with Global Zero Waste launched its Circular Economy Programme, that will allow issuance of material credits, starting with plastics.

Likewise, within the framework of COP28 in Dubai, Cercarbono launched the public consultation of its biodiversity protocol, for the formulation of projects intended to be financed by these market mechanisms.

2023 was an outstanding year for Cercarbono, both in figures and in concrete facts driving our future growth. I sincerely thank the entire team for their technical quality, dedication and commitment, as well as our customers for placing theit trust on us. We will continue to work tirelessly to make Cercarbono one of the best standards globally.





Executive Summary

Over the last year, Cercarbono in consistency with its functions and scope as per in its objectives, has expanded its services as an international standard, including in its portfolio certification processes for three environmental programs: carbon, circular economy and biodiversity.

With the carbon programme, Cercarbono is now positioned in 15 countries of Africa, America, Asia, and Europe, confirmaning its leadership in the international voluntary carbon market. This program continues building and strenthening its regulatory and technical framework including methodologies, tools and auidelines. relevant to ensure transparency in certification processes for 159 programs/projects registered in 9 sectorial scopes participating in the voluntary market with integrity and technical rigor, which is further explained in the following sections.

2023. Cercarbono received the In endorsement of the International Carbon Reduction & Offset Alliance (ICROA), its carbon credits were accepted as eligible for the Queretaro carbon market and was recommended by Technical Assessment Board (TAB) of the Carbon Offsetting and Reduction for International Aviation (CORSIA) for conditional approval in its first phase (compliance cycle 2024-2026). This will enable Cercarbono's credits from industries and the energy waste management sectors to be considered under CORSIA regime once the process has concluded and approval is granted.

Our governance scheme and system has been strengthened, and is enforced for governing the operation of Cercarbono's different organs and positions as related to their functions and decision-making process, providing certainty and transparency to involved actors. Currently, revision of regulatory framework is being carried out, along with the development of the Guidelines for Mapping Presentation and Analysis, aligned with the principles considered as fundamental for carbon programmes and credits at the international level. enhancing the procedures to prevent and potential double-counting manage events and prevent overlaps among initiatives, considering also the countries' accounting national adjustments information needs for Nationally Determined Contributions (NDC) management, under Article 6.4 of the Paris Agreement.

At the same time, a rigorous system for Cercarbono's own methodologies review and updating has been put in place, with the participation of independent third-party experts, thus in the second quarter of 2024 updated and enhanced versions of such documents will be published.









5. Project registry dynamics





6. Registered projects by type of mitigation activity




7. Sectoral distribution of projects certified in 2023




As a means of supporting the permanence criterion for GHG removals and GHG emissions reductions achieved in the AFOLU sector, the carbon programme has a total carbon buffer of 9,196,909 tCO2e, formed by 6,384,250 tCO2e in a collective buffer and 2,812,659 tCO2e corresponding to individual buffer, the latter subject to release once the project demonstrates suitable implementation. In 2023, a total 149,447 tCO2e were released from the individual buffer. Cercarbono will update policies regarding this release in 2024.

A total of 24 projects have migrated from other standards to Cercarbono. A project that was not referenced in the previous annual report and migrated in 2020 from CDM is updated in the current graph.

Cercarbono updates its documents and develops templates to keep up with international normative and foster carbon market's transparency, seeking at the same time facilitating projects' formulation and implementation to project holders and developers.






15. Circular Economy Programme regulatory and technical documents

Programme ensures that validation, verification, and certification processes are adequate, reliable, impartial, and transparent.







17. Launching of the Biodiversity Programme

Cercarbono Biodiversity Certification Programme (CBCP) aims to enable the quantification, verification and credible certification of the positive results of biodiversity conservation activities. Providing a robust set of criteria and requirements.

To certify net biodiversity gains, the programme aims to unlock new sources of funding for urgent actions around the world. Methodologically sound biodiversity crediting that is transparently certified can appropriately channel investment from public climate funds, corporations, and financial institutions to projects delivering lasting ecosystem service benefits and contributing to global biodiversity goals.

The protocol developed by Cercarbono specifies the requirements for the issuance of Voluntary Biodiversity Credits (VBCs) under the CBCP.

The biodiversity protocol was in public comments since December 1, 2023 and its methodology on December 26, 2023.





Cercarbono, as an international certification standard, is consolidating its regulatory and technical framework, applicable to project cycle for all environmenta projects it operates in and will operate, such as Carbon, Circular Economy and Biodiversity.

In this direction and consistent with its strategic planning, Cercarbono adopted an integral training plan to promote adequate interactions between stakeholders involved in such environmental programmes, highlighting the role each one has at the different stages of the certification cycle. This way, in 2023 Cercarbono opened different training spaces, three of them within its carbon certification framework, and two more to establish the foundations of its circular economy program, entering into operation shortly, as described below:
